SECURE ACT

The SECURE Act federal legislation was passed in late 2019 and affects IRAs and 401(k)s as of January 1, 2020. Many of our clients have asked how this could affect their planning. As expected, the law is not simple and there is not one universal approach.

The SECURE Act eliminates the ability to stretch the distributions from an IRA or 401(k) over the life expectancy of a beneficiary and replaces that life expectancy stretch with a requirement that the beneficiary must take full distribution of an IRA or 401(k) by the tenth (10th) anniversary of the participant's death.
