Change in Texas Law Regarding Trusts

Last year we sent an email about a change in Texas law that would permit trusts to last 300 years before becoming subject to estate tax. These trusts are known as Dynasty Trusts or Generation-Skipping Transfer Trusts because it skips the estate tax for multiple generations. We recommended an amendment to your revocable trusts to take advantage of this change in law, but noted that this was a bit more complex to address in irrevocable trusts.

It was initially thought that an irrevocable trust would require a court to modify the terms of the trust to take advantage of the new law, which may be unduly burdensome and expensive with no guarantee that the court would approve the requested change. The law is still developing in this area, and it's not yet clear as to whether this is necessary.

But for those irrevocable trusts that qualify, we are recommending that a beneficiary exercise a testamentary special power of appointment to determine the appliable term of future trusts created under that irrevocable trust. After research and several seminars, it is our belief that this may be a solution to take advantage of the change in Texas law to extend the trust term to 300 years.

If an irrevocable trust does not grant a beneficiary a testamentary special power of appointment, then the exercise of such power is not possible and we will continue to monitor the law to determine your options to extend the trust term to 300 years.
